A position specification description sets forth criteria and considerations for the positions. In addition, candidates for the Board and the Board Development Committee must meet the following minimum criteria:

1. Accept the principles, beliefs, and purpose of Girl Scouting.
2. Understand cultural, social, and economic trends nationally and internationally and their effect on Girl Scouting and its activities.
3. Be available to attend board and committee meetings.
4. Be a citizen of the U.S.A., required by GSUSA Congressional Charter and Constitution.
5. Be a minimum of 18 years of age at the time of election.
6. Be willing to make a meaningful, personal gift to GSUSA's Annual Fund and/or solicit significant gifts.
